HBF Product Selection Guidance

As of April 2019, HBF products can meet the Safer Chemicals Challenge of the Healthier Hospitals Healthy Interiors Goal version 2.0 (November 2015) by using the following guidance. Customer choice plays an important role in avoiding undesired chemicals and treatments. Furniture and options specified must meet all criteria below.

Formaldehyde* 1.

HBF furniture that is Indoor Advantage^(TM) Gold certified qualifies. Exclusions, if applicable, are listed on each certificate which is publicly available on the SCS Global Services Website: https://www.scsglobalservices.com/certified-green-products-guide

2. Perfluorinated Compounds (PFCs)*

PFC-free fabrics are available. Customers are responsible for the COM fabric treatments and chemical contents.

Polyvinyl Chloride (PVC)* 3.

Conference: some small parts, electrical casings and some non-work surface edges may contain PVC in an amount less than 1% of the total product weight. Non-PVC edge banding is available for laminate work surfaces. Veneered work surfaces are PVC free.

For seating products, PVC based Vinyl upholstery fabrics must be avoided.

Antimicrobials* 4.

Antimicrobial-free fabrics are available. Customers are responsible for the COM fabric treatments and chemical contents.

Flame Retardants* 5.

All product lines can meet the HH requirements unless specifically ordered to meet CAL133 and the City of Boston fire code. Some fabrics may contain flame retardants, so customers must select flame retardant free fabrics. Some Vinyl upholstery, polyurethanes, and some high-performance textiles must be avoided. Customers are responsible for the COM fabric treatments and chemical contents.

Example HBF Textile patterns that meet the HH guidelines include but are not limited to: Afghan, Attaché, Aviator, Beetle, Bunny, Burlap Rug, Changing Lanes, Complex, Cork Cloth, Crosshatch Cloth, Crosstweed, Dashing, Deco Epingle, Double Stitch, Embossed Woven, Equation, Flirt, Folded Lines, Fourfold, Free Way, Glove, Heartfelt, Italian Wool, Knitwork, Madam Dottie, Merci Boucle, Modern Patina, Moving In, Pearl, Pepper Blend, Poodle, Sable Island, Scribble XL, Sideways, Smart, Squiggle Stripe, Sweater, Twist, Upper Crust, Velvet Mix, Vivace II, Voyage, Weekender, Wild West

Please note that it is not feasible to provide laboratory testing data of product and materials. HBF has worked with our suppliers to determine whether the chemicals and treatments listed are not included in products above the guideline threshold limits unless specifically ordered by the customer. Customers are responsible for the chemical treatments and content of COM fabrics.
